The Ministry of Infrastructure and Watermanagement presented the final package of measures on Wednesday 4 September, to reduce noise around Schiphol and restore legal protection for local residents. This package will reduce noise pollution around Schiphol by 17%; and that's only the beginning.

The government maintains a bandwidth of 475-485.000 movements; the calculations by external experts still have to be finalized. However we count on a minimum of 483.000 as these are the total of historical slots. Anything below might trigger retaliation. The Netherlands sometimes forgets we are part of a larger entity and are bound to international obligations.

Last but not least the package of measures of Minister Madlener implies billions of investment of airlines and Schiphol and a pressure on its revenues. At the same time we are happy to conclude an unfortunate chapter, after two years of fire crackers and turmoil.

We call upon all stakeholders to work jointly together to further reduce noise and emissions.

Notification on Balanced Approach reduction Schiphol sent to European Commission

Last week Wednesday, September 4th, the Minister of Infrastructure & Watermanagement, Mr. Barry Madlener sent a moldified notification on the Balanced Approach regarding the intended reduction of air traffic movements (atm's) at Schiphol to the European Commission in Brussels. Main changes to an eaerlier notifaction are:

- Reduction from 500.000 to a bandwidth of 475.000-485.000 atm's.
- Reduction of 5.000 night movements from current 32.000 to 27.000
- Stimulation of using most quiet aircraft during the night
- Banning of noisiest aircraft during the night
- Increase in airport charges for noisiest aircraft

Although still a considerable challenge for the aviation industry, we are happy to be able to move forward and jointly make an effort to reduce noise hindrance around the airport.
