The municipal government in The Hague decided last week that outdoor advertising of airlines is not allowed any longer, and Amsterdam announced their staff can only travel by air if travelling time by train is more than 10 hours..

The first one is an example of "symbol-politics" and from a legal perspective debatable.

Or are they also going to put a ban on advertising for food, clothes, etc.? All generating significantly more emissions than our industry.

Outdoor advertising generates € 5 million income annually for The Hague. To be compensated by increasing taxes?

Amsterdam is setting the wrong example as apparently the price of a ticket is not important. Neither the cost of travelling for 20 hours.

Personally I am a big fan of travelling by train, as long as it is within 3 hours travelling time and reasonably priced. Of course if you want to buy a train ticket to

Schiphol final consultation on Airport Charges 2025-2027

On Thursday 26 September the final consultation of the airlines on the proposed tariff increases for the period 2025-2027 is being conducted by Schiphol. BARIN supports the investment plan of Schiphol with its aim to bring the airport back to where it belongs, being one of the top 3 airports in Europe. BARIN does understand that maintenance and upgrades are necessary to become a leading airport again. At the same time a € 6 bln (..) investment plan implies as well a need for significant efficiencies and strict budget control. BARIN will make a strong statement during the meeting, and defend the interests of its members.



Implementation European Entry/Exit System drawing nearer

As communicated earlier, a new European border control system called EES (Entry/Exit System) is to be implemented in November this year. All airports and governments are in the final phases of making the necessary adjustments in border-crossing operations for non-EU nationals.
