<u>Version 2.0 of this Policy Rule</u> will be effective from W24.



Implementation of Europe's Entry & Exit System further delayed

The initial implementation of the Entry & Exit System (EES) for non-EU nationals entering the European Union planned for November 2024 has been further delayed due to the fact that a number of member states have indicated not being ready for the implementation. A new date has not been set yet, but is not likely to happen in 2024.
