You might have noticed quite some media attention recently on the increase of airport charges by Schiphol .

Few important elements to remember:

- 40% increase 2022/24
- another 37% increase 2025/27
- Schiphol will become the second most expensive airport in Europe.
- Schiphol included in the charges a significant amount of lost revenues due to.. remember Corona? Fair?
- Schiphol included in the charges an unacceptable amount for the infamous A-Pier, now calculated at € 1.3 billion; 3 times the original budget. Fair? Over the past six months we debated with Schiphol for hours and hours, days after days. However, as of day one it was crystal clear they wanted the unreasonable maximum. As it is defined in the Aviation Act, as long as it's reasonable and they

follow the procedures, Schiphol can unilaterally define the end result .

Summarizing: more than enough arguments to appeal at the ACM.

Time to change the Aviation Act?

I mentioned in another Flash Update that the city of The Hague bans outside advertising (billboards etc) of airlines, tour-operators . As I assume this wonderful city is aware our industry is responsible for 2-3% of $\rm CO_2$ emission, will they also ban advertising of more polluting products like clothes, super markets, mobile phones , fast food restaurants etc.?

BARIN supports the initiative of travel industry organization ANVR who is taking the municipality of The Hague to court.

Schiphol and security companies join forces for long-term collaboration

In an effort to come to a closer cooperation with the various security companies at the airport,
Amsterdam Airport Schiphol announced the set-up of three security companies in which Schiphol will be taking a 25% share. The remaining 75% of the ownership will remain in the hands of the security companies themselves. For the selection of the 3 security companies, Schiphol has started a European tender process which should be finalized by February 2026.
