In a fine interview in De Telegraaf of last Saturday March 15<sup>th</sup>, Berdowski warned again against too rigid policies and regulations. Boskalis with a worldwide presence and fleet still has the possibility to move

(part of) its business elsewhere; likewise for Unilever, Shell, Samsung, Nike or Canon, whereas this is impossible for Dutch airlines. Also disastrous for our economy, but for foreign airlines it's 'easier' to move their operation from Schiphol to Düsseldorf or Paris. I sympathize with those who are "obsessed with saving the world".

But ... it's also my concern, this detachement of political goals from the (economic) reality!

Too often we are confronted with rules or policies which are detached from the reality, from the "real world" the airline industry operates in. Often based on the misunderstanding that we are the epic centre of the world.

Having said this, of course we do fully support our common goal. Make this world a better place. A sustainable operation is your license to operate, and less noise, less emissions is our joint objective. The economic reality of our industry is that in the Netherlands more than 100.000 people are directly employed in aviation, generating US\$ 10.5 billion of economic output. Even more additional benefits are generated by the wider supply chain. Tourism alone already contributes US\$ 7.1 billion to our GDP and more than 400.000 jobs.

Political goals should take this into account. Full stop.

# Planning Bureau for the Living Environment published report on toxic emissions

Earlier this month the PBL (*Plan Bureau voor de Leefomgeving* – Planning Bureau for the Living Environment), published a report on the reduction of various emissions over the past decades. The reduction shows a steep decline and the expectation is that it will further drop in the coming years.

Herewith the chance is fairly big that the European emission goals for air polluting substances by 2030 will be met. But despite a drastic expected reduction of the emission of ammonia the legal national goals for reduction of NOx depositions in nature are still far from within reach.
